A. BASIC TERMS

1.	Organiser	MEASAT BROADCAST NETWORK SYSTEMS SDN BHD [Company No. 199201008561 (240064-A)]
2.	Name of Contest	JomPAY & WIN today!
3.	Brief Description of Contest/ Programme	"JomPAY & WIN today!" is a contest organized by the Organiser in collaboration with JomPAY to reward Astro Bill JomPAY transactions and Astro's cash paying customers converted to online/bank paying customers during the Contest Period, with Astro bill rebates and cash prizes.
4.	Brief mechanism of Contest	<p>Eligible Contestants are required to make payment for their most recent Astro bill in full (i.e. pay a sum equal to the outstanding amount under their latest Astro bill) through JomPAY and/or register Astro as their favourite JomPAY biller as per the Entry Procedure in Clause 11 below during the Contest Period and will stand a chance to win a Daily Prize of a one-off RM5 bill rebate for his/her Astro account and/or a Grand Prize of RM1000 cash.</p> <p>The Daily Prize is only applicable to Astro accounts:</p> <ul style="list-style-type: none"> (a) which are not subject to any payment through JomPAY in the past six (6) months from the start of the Contest; and (b) with successful full outstanding bill payment via a single JomPAY transaction. <p>For the avoidance of doubt, Astro accounts with JomPAY arrangement in the past six (6) months from the start of the Contest and/or splitting of bill payment via multiple JomPAY transactions are not entitled to the Daily Prize.</p> <p>The Grand Prize is only applicable to Astro accounts:</p> <ul style="list-style-type: none"> (a) with successful full outstanding bill payment via a single JomPAY transaction; and (b) with Astro newly registered as a JomPAY favourite biller during the Contest Period. <p>For the avoidance of doubt, Astro accounts with splitting of bill payment via multiple JomPAY transactions and/or with Astro being an existing JomPAY favourite biller as of the start of the Contest are not entitled to the Grand Prize.</p> <p>The Contestants must adhere to the mechanism of the Contest as may be notified or communicated by the Organiser during the Contest Period.</p>
5.	Eligibility Criteria	<p>Subject to other criteria set out below and in the Contest Standard Terms and Conditions, the Contest is open to all Malaysian citizens of the Age of Eligibility below who are *Astro customers.</p> <p><i>* "Astro customers" means a subscriber of the Astro Service and whose account is current and who has not breached the Astro subscription agreement nor given any instructions to terminate and/or suspend his/her subscription to the Astro Service as at the date of winner notification. Winners must remain Astro customers until the date of collection of Prizes.</i></p>
6.	Ineligibility	<p>Employees and scholars of Astro Malaysia Holdings Berhad and its Group of Companies, and their **immediate family members.</p> <p><i>** "immediate family members" means spouse, children, parents, brothers and</i></p>

7.	Age of Eligibility	18 years of age and above as at 1 November 2020.
8.	Charges	The Organiser does not charge Contestants for Contest participation.
9.	Contest Period	From 12.01am, 1 November 2020 to 11.59pm, 31 January 2021. The Organiser reserves the right to vary, postpone or re-schedule the Contest Period or any dates thereof at its sole discretion.
10.	Language of Contest	The Contest will be organized by the Organiser in English.
11.	Entry Procedure	<p>To participate in the Contest, eligible Contestants must make full outstanding bill payment and/or favourite the Astro biller via JomPAY for the relevant Astro account per Clause 4 above through his/her Online Banking JomPAY portal platform from one of the banks as stated in Clause 14 below during the Contest Period as follows:</p> <ol style="list-style-type: none"> 1. Look for JomPAY Biller Code and Reference Number on the relevant latest Astro bill; 2. Log in to Internet or Mobile Banking of the relevant Bank; 3. Add Astro as favourite JomPAY biller*; and 4. Pay such latest Astro bill in full via JomPAY. <p>*Some banks may require a payment to be made prior to registration of favourite biller. Contestants should contact his/her bank for more details.</p> <p>The Organiser shall be entitled to request to sight the original Identity Card or the originals of other supporting documents/materials for verification purposes.</p>
12.	Entry Deadline	<p>Entries must be received by the Organiser on or before 11.59pm on 31 January 2021.</p> <p>Note:-</p> <p>It shall be the eligible Contestants' responsibility to ensure compliance of the stipulated Entry Deadline taking into account the timeframe in having their funds received from initiation of successful JomPAY transaction and/or their favourite JomPAY biller registered from submission of application. The Organiser reserves the right at its absolute discretion to approve or reject any application/request in relation to JomPAY and/or the supporting documents.</p> <p>Entries received before the commencement of the Contest Period and after the stipulated Entry Deadline will be disqualified and ineligible for consideration for prizes.</p>

Selection of Winners	<p><u>Daily Prize Winner x 150 for each day during the Contest Period</u></p> <ul style="list-style-type: none"> • The first one hundred fifty (150) eligible Astro accounts with successful full outstanding bill payment via a single JomPAY transaction as outlined in Clause 4 above will be selected as the Daily Prize Winners. <p><u>Grand Prize Winner x 9 at the end of the Contest Period</u></p> <ul style="list-style-type: none"> • Nine (9) Grand Prize Winners will be selected based on a certain sequence of entries made by the eligible Contestants who successfully made full outstanding bill payment via a single JomPAY transaction and registered Astro as their favourite JomPAY biller as outlined in Clause 4 above. The determination of the sequence is based on the following formula: $X = \frac{a}{b}$ <p>where X is the sequence (N.B. in the event that the sequence is in decimal form, such number is to be rounded up or down, as the case may be) a is the total number of eligible Grand Prize entries received by the Organiser b is 9 (i.e. total number of Grand Prize)</p> <p><i>For example:</i></p> <p>(a) if there is a total number of 90,089 eligible Grand Prize entries received by the Organiser, the sequence will be $90,089 / 9 = 10,009.89$ which will be rounded up to 10,010 whereby the 10,010th, 20,020th, 30,030th, 40,040th, 50,050th, 60,060th, 70,070th, 80,080th and 90,089th eligible Grand Prize entries will be the Grand Prize Winners, subject to eligibility criteria.</p> <p>(b) if there is a total number of 90,001 eligible Grand Prize entries received by the Organiser, the sequence will be $90,001 / 9 = 10,000.11$ which will be rounded down to 10,000 whereby the 10,000th, 20,000th, 30,000th, 40,000th, 50,000th, 60,000th, 70,000th, 80,000th and 90,000th eligible Grand Prize entries will be the Grand Prize Winners, subject to eligibility criteria.</p> <p>In the event that the number of eligible Grand Prize entries does not reach the requisite number, the Organiser shall be entitled to determine the Grand Prize Winners following any other sequence of entry at its sole discretion.</p> <p>The winners' data comprising of JomPAY Ref Number will be shared for the purpose of verification. This is meant for selecting the winners of those who set Astro as their JomPAY favourite payee.</p> <p>The Organiser's decision will be final and no queries and/ or appeals will be entertained.</p>

18.	Collection Period	<p>Within one (1) month from Notification of Winners by the Organiser or such other period as stipulated by the Organiser.</p> <p>Prizes not collected within the stipulated period will be forfeited.</p>
19.	Collection Venue	<p>Daily Prize will be reflected in the Astro Bill of the relevant Astro account from that of December 2020 onwards depending on such Astro accounts' billing cycle. The Organiser reserves the right to vary the date and the frequency of crediting the Daily Prize at its sole discretion.</p> <p>Grand Prize Winners are required to collect the Grand Prize at such location to be notified by the Organiser.</p>
20.	Additional Terms, if any	<p>a) Eligible Contestants may submit multiple Daily Prize entries for multiple Astro accounts in this Contest during the Contest Period. However, each Astro account is only entitled to one (1) Daily Prize throughout the Contest Period. Any subsequent Daily Prize for the same Astro account (if declared) will be automatically void.</p> <p>b) Eligible Contestants may only submit one (1) Grand Prize entry for multiple Astro accounts in this Contest during the Contest Period. Furthermore, each eligible Contestant is only entitled to one (1) Grand Prize throughout the Contest Period. Any subsequent Grand Prize for the same eligible Contestant (if declared) will be automatically void.</p> <p>c) The reward of the Prize is subject to the respective banks' prevailing terms and conditions governing the use of the credit / debit cards and bank accounts.</p> <p>d) Any refund/ chargeback request after successful payment will be based on the actual amount stated in the bill statement.</p> <p>e) In the event the credit / debit cards and/or bank accounts which is used to perform the JomPAY transaction for the Astro account does not belong to the corresponding Astro customer of such Astro account, the Prize is to be awarded to the relevant Astro customer and not to the third party credit / debit cards or bank accounts holder.</p> <p>f) The Terms and Conditions herein shall be read together with the provisions in the prevailing terms and conditions governing the JomPAY arrangement i.e. JomPAY Terms and Conditions. In the event of any discrepancy or inconsistency between the Terms and Conditions herein and those contained in the JomPAY Terms and Conditions, these Terms and Conditions governing the benefits of the Prize shall prevail in so far as they apply to the Prize / Contest.</p>
