3.	<b>Brief Description of Contest/ Programme</b>	"ASTRO REWARDS RAYA 2022 CONTEST" is a contest organised by the Organiser to reward Astro Pay TV customers for their loyal support.  Individuals who adhere to the eligibility criteria as set out in the Terms and Conditions are entitled to participate in this Contest and stand a chance to win Prizes.
